- Students entering on or after March 27, 2023 to pay 25% of the annual tuition fees.

FEE PAYMENT POLICIES

NEW STUDENTS

Application Fee: non-refundable and payable when the student's application is submitted. An application is not considered complete until this fee has been paid. The fee is valid for the school year for which the application is submitted.

Non-Refundable Enrollment Deposit: due within 15 days of accepting an admission offer (or before the first day of attendance), whichever is earlier. This payment is used to secure the place for the student and is credited towards Semester 2 tuition fees.

Student Registration Fee: non-refundable and payable in full with the initial tuition fee invoice. This fee applies to new students entering Prep-Senior to Grade 12 and when a Prep Junior student enrolled in or after August 2022 advances to Prep Senior.*

This fee is used for costs associated with investments in, and maintenance of, campus facilities and technology. This is a one-time, non-transferable fee, and is valid for a 12-month period from the date of the admission offer. It includes a nominal (RM 50) one-time Society Membership Admission Fee to admit the family into the ISKL Society.

* In recognition of having previously paid a one-time Family Registration Fee, ISKL families whose eldest child was enrolled in Prep Senior and above prior to 2022-2023 will continue to pay Student Registration Fees according to the prior schedule (subject to change).

RETURNING STUDENTS

Non-Refundable Enrollment Deposit: payable by April 1, and credited towards the Semester 2 Tuition Fee payment. This fee is used to secure a place for returning students in the next school year.

Annual Tuition Fee: may be paid in full by July 1, or in two parts: Semester 1 Tuition Fees due by July 1 (55%) and Semester 2 Tuition Fees due by December 1 (45%). Fees are payable in advance of the start of each semester, in order to allow the school to manage enrollment accordingly. A remittance rebate of RM 200 is offered to those who pay 100% of a student's tuition fees in advance. Tuition Fees are used to support the general annual operations of the school and include a nominal (RM 20) annual Society Membership Subscription Fee.

ADDITIONAL FEES

- External exam fees, associated registration and courier costs for examinations marked and graded by an external examining board for example, IB, AP will be invoiced separately.
- ISKL provides opportunities for students to engage in curricular and co-curricular activities and parents may be required to contribute toward the costs incurred on certain specified activities. The High School Global Action Program (GAP) is mandatory for Grade 9-11 students and is a graduation requirement. A separate non-refundable GAP fee is charged based on the destination selected.

REFUNDS

All fees are non-refundable, except in the case of Tuition Fees where a refund of 50% of the applicable semester fees will be granted if formal written notice of withdrawal is received after July 1 or December 1 and before the official first day of school on August 11, 2022 and January 9, 2023. If written notice is not received before the official first day of school, no refund will be granted, even if the student has not attended school. Students having attended a day of class are contractually liable to pay the full fees.

PAYMENT

All Fees are set and are payable in RM (Ringgit Malaysia). In exceptional circumstances, USD-based invoices and payments may be arranged. Payment must be made by one of the following methods, indicating student name(s) and Family Number by:

All payments made must be net of any bank charges (wire transfer charges, etc), which are the responsibility of the payer. The parent must provide proof of payment for wire transfers and direct deposits, even if payment is made by a sponsoring entity.

An installment plan is available. Please contact the Finance Office for an application. Terms and conditions apply.

A 2.5% surcharge will be levied on any balance of fees not paid within 30 days of the due date and an additional 2.5% will be levied on any balance of fees not paid within 60 days of the due date. Failure in paying fees by the stipulated due date carries consequences including withholding of student records and the exclusion of a student from school until fee payments are settled in full.
